Non flammable. May evolve carbon oxides and hydrocarbons when heated to decomposition. Following evaporation of the water component of the material, the residual material can burn if ignited.

Wear full protective equipment including Self Contained Breathing Apparatus (SCBA) when combating fire. Use waterfog to cool intact containers and nearby storage areas.
